  - a. Enrollment: Current school enrollment is 348 students. Goal is working towards 52% of students with Alt. Ed. status, currently at 47% of students with Alt. Ed. status.
  - b. Community Engagement: Board had first-hand account into the Improve Your Tomorrow presentation as an example of the community engagement projects in the work. Focus currently is on developing community partnerships and providing the right resources and support for kids.
  - c. Facilities: Made outlet and HVAC changes to redirect airflow from the attic to the roof. All changes are complete.

- d. Operations: Testing is coming up for students and the school will need to purchase additional Chromebooks to facilitate all required testing. These funds can be refunded via the CSP Grant but will require board approval before purchase because of the cost. The attendance audit results have been delivered and we are making corrections, based on the feedback provided, to our student plans of study and distance education plans.

School Performance Data: Reviewed Learning Period 3 performance data, the pass rate saw a minor dip from 69% to 68%, but the key metric of C and above letter grades increased from 48.4% to 68.5%. Overall decrease in the amount of D's earned with an increase in the amount of B's earned. Math courses saw the largest increase in earned letter grades.
